

**Form of order sought**

- Annul the contested decisions and, where necessary, the decisions rejecting the complaints;
- order the defendant to pay the applicants the arrears of remuneration corresponding to an adjustment of their salaries and pensions at the rate of 1,7 % in 2011 and 2012, by way of compensation for the financial material loss, together with interest for delayed payment at the European Central Bank rate plus 2 points, as of 1 July 2011 and 1 July 2012;
- order the defendant to pay the costs.

**Action brought on 24 February 2015 — ZZ v Commission****(Case F-35/15)**

Application for annulment of the Commission's decision not to take further action on the request for assistance made by the applicant even though he was under investigation for misappropriation of funds accruing to the Community budget.

**Form of order sought**

The applicant claims that the Tribunal should:

- annul the decision of the appointing authority of 21 November 2014, received on 3 December 2014, rejecting complaint No R/865/14 submitted by the applicant on 5 August 2014;
- order the European Commission to pay the sum of EUR 17 242,51, to be adjusted if necessary;
- order the European Commission to pay the sum of EUR 3 000 in respect of the non-recoverable costs, to be adjusted if necessary, and to pay all the costs.

**Action brought on 27 February 2015 — ZZ and ZZ v Court of Justice****(Case F-36/15)**

**Subject-matter and description of the proceedings**

Application for annulment of the decisions fixing the applicants' rights to reimbursement of annual travel expenses pursuant to Article 8 of Annex VII to the Staff Regulations of Officials, as amended by Regulation No 1023/2013 of the Parliament and of the Council of 22 October 2013 amending the Staff Regulations of Officials and the CEOS.

**Form of order sought**

The applicants claim that the Tribunal should:

- annul the applicants' salary slips in respect of July 2014 in so far as they apply for the first time Article 8 of Annex VII to the version of the Staff Regulations in force since 1 January 2014 in order to fix the reimbursement of their travel expenses;
- order the Court of Justice to pay the costs.
