

Action brought on 8 August 2022 — Cyprian Iwuć v EUIPO — Hangzhou XiangHui (Packaging boxes, Socks (Set of -))**(Case T-492/22)**

The applicant claims that the Court should:

- annul the contested decision and, accordingly, declare the contested design invalid; in the alternative, if the contested design is not deemed to lack novelty as a whole, limit, on the basis of Article 25(6) of Council Regulation (EC) No 6/2002, the registration of the contested design to the cardboard box;
- order EUIPO and the other party to the proceedings before EUIPO to pay the costs of the proceedings before the Board of Appeal; order EUIPO to pay all the costs of the present proceedings.

Plea in law

- Infringement of Article 5(1)(b) and Article 7(1), in conjunction with Article 63, of Council Regulation (EC) No 6/2002 on Community Designs, read in conjunction with Article 28(1)(b) and (v) of Commission Regulation (EC) No 2245/2002 implementing Council Regulation (EC) No 6/2002.

Action brought on 12 August 2022 — NSD v Council**(Case T-494/22)**

- annul Council Implementing Regulation (EU) 2022/878 of 3 June 2022 implementing Regulation (EU) No 269/2014 concerning restrictive measures in respect of actions undermining or threatening the territorial integrity, sovereignty and independence of Ukraine,⁽¹⁾ and Council Decision (CFSP) 2022/883 of 3 June 2022 amending Decision 2014/145/CFSP concerning restrictive measures in respect of actions undermining or threatening the territorial integrity, sovereignty and independence of Ukraine,⁽²⁾ in their entirety insofar as they affect the applicant;
