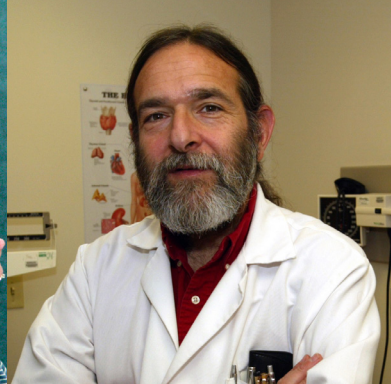
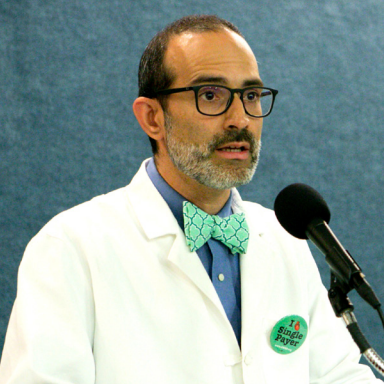

Why single payer?

Americans spend trillions on health care, and what do we have to show for it? Subpar health outcomes, physician burnout, and millions of medical bankruptcies. We need fundamental reform and we need it now.

Good for patients: Single payer would provide comprehensive benefits and free choice of medical provider while eliminating the cost-sharing that keeps people from seeking care.

Good for physicians: Single payer would do away with private insurance overhead. This would allow doctors to ditch the paperwork and focus on what they do best: caring for patients.

Good for public health: Single payer would allocate our ample financial, medical, and scientific resources based on medical need, not the potential for profit.

Americans deserve an efficient, effective, and humane health care system. Single payer, aka improved Medicare for all, can deliver.
